This term **does not** include news, weather or current events program; a production that is primarily produced for industrial, corporate or institutional use; a telethon or any production that solicits money, other than a production which is produced for national distribution; a political advertisement; a sporting event; a gala or award show; and other type of production that is excluded by regulations adopted by the Office of Economic Development pursuant to **NRS 360.759**. Any type of production featuring obscene or sexually explicit material, is not eligible for transferable tax credits **NRS360.759(8)(a)(5)**.
